CONSENT FOR CRIMINAL HISTORY RECORDS CHECK

I hereby give my permission to U.S. Figure Skating and North Carolina 2011 to obtain information relating to my criminal history record through a reporting agency that regularly performs background checks. I understand that I may be required to provide a set of my fingerprint impressions for the records check to be completed. If I am not required to provide fingerprint impressions, I understand that the records check will be conducted based on my social security number. The criminal history record, as received from the reporting agencies, may include arrest and conviction data as well as plea bargains and deferred adjudications and delinquent conduct committed as a juvenile. I understand that this information will be used, in part, to determine my eligibility for a volunteer position at the 2011 U.S. Figure Skating Championships. I also understand that the criminal history could contain information presumed to be expunged.

I, the undersigned, do, for myself, my heirs, executors and administrators, hereby remise, release and forever discharge and agree to indemnify and hold U.S. Figure Skating and North Carolina 2011 and the organization performing the background check and each of their respective officers, directors, employees, and agents harmless from and against any and all causes of actions, suits, liabilities, costs, debts, and sums of money, claims and demands whatsoever (including claims for negligence, gross negligence, and/or strict liability of U.S. Figure Skating and North Carolina 2011 and the organization performing the background check) and any and all related attorneys' fees, court costs and other expenses resulting from the investigation of my background in connection with my application to become a volunteer for the 2011 U.S. Figure Skating Championships.
